### **OLD BUSINESS**

 A home under construction on Cape View included a solid concrete block wall that violated not only the DOR but also County Code. The wall was not identified on the plans which were approved. Following a complaint by an adjacent homeowner and through the efforts of the HOA and County, the wall has been deconstructed.

#### **NEW BUSINESS**

- No solicitation signs for neighborhood were destroyed by lan and may incorporate into new sign design
- Seven (7) dead trees in neighborhood that have not been removed and will receive violation letters
- Florida Laws regarding Homeowner Associations to take effect December 31, 2025 will need to be addressed by the Board of Directors
  - Ann Marie to send soft copy electronically to the Board for review
  - Some of the new law only effects Condos
  - The President of the Board will need to follow-up with the Attorney on Town and River Deed of Restrictions compliance with the new law.
- Sinkholes along seawalls in Deep Lagoon are needing remediation
  - o Bring in Honc to review and advise a plan of action
  - Board to discuss finalization of remedy for approval

#### **Homeowner Comments**

- Bal Isle homeowner requested information regarding an attorney being hired to access insufficient drainage on Bal Isle Drive
  - Board will need to follow up to gather information about the drainage.
